The Chair of Orthopaedics and Rehabilitation plays a major leadership role in all Health Sciences mission areas. Minimum Qualifications:

The Chair of Orthopaedics and Rehabilitation must hold an MD, MD-PhD, DO, or equivalent medical degree and be Board Certified in Orthopaedic Surgery. The candidate must have demonstrated expertise appropriate for appointment as an Associate Professor or Professor at the University of New Mexico School of Medicine. The candidate must have at least five years of administrative and leadership experience in an academic institution, be eligible for licensure in New Mexico, and must be eligible to work in the United States.

The chair must be a person of high integrity with a significant record of achievement in academic medicine.
